RESOLUTION OF THE TOWNSHIP OF LOPATCONG, COUNTY OF WARREN AND STATE OF NEW JERSEY AUTHORIZING APPLICATION TO THE NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS FOR THE FY2021 LOCAL RECREATION IMPROVEMENT GRANT

WHEREAS, the Township of Lopatcong, County of Warren and State of New Jersey is eligible to apply for grant funding from the New Jersey Department of Community Affairs for the FY2021 Local Recreation Improvement Grant up to the amount of \$500,000.00 to repair and improve the condition of our Township Pool; and,

WHEREAS, the grant program desires applicants to contribute an in-kind match of any funds received; and,

WHEREAS, the Township Council wishes to authorize the Township to prepare and sign the grant application, approve the in-kind match of 50%, authorize the Mayor and Administration to execute the grant agreement and accept and utilize any resulting grant funds in accordance with the grant agreement.

- **NOW, THEREFORE, BE IT RESOLVED,** that the Township Council of the Township of Lopatcong hereby approves the completion and submission of a grant application for the above stated program; and,
- **BE IT FURTHER RESOLVED,** that the Mayor or his designee is hereby authorized to execute the grant agreement on behalf of the Township of Lopatcong with the New Jersey Department of Community Affairs and the signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement; and,
- **BE IT FURTHER RESOLVED,** that the Town Council authorizes an in-kind match of 50% for the project contingent upon the award of grant funding from the New Jersey Department of Community Affairs; and,
- **BE IT FURTHER RESOLVED,** that the Mayor and Administration are authorized to utilize any funds received from the grant agreement in accordance with the terms of the agreement and the goals and objectives outlined above.
