The Regular Meeting of the Lopatcong Township Council was called to order by Mayor Mengucci. The meeting was held in the Municipal Building located at 232 S. Third St., Phillipsburg, New Jersey.

A Prayer was offered followed by the Oath of Allegiance.

Mayor Mengucci stated "adequate notice of this meeting has been provided indicating the time and place of the meeting in accordance with Chapter 231 of the Public Laws of 1975 by advertising a Notice in The Star Ledger and The Express-Times and by posting a copy on the bulletin board in the Municipal Building."

CALENDAR YEAR 2022

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS

AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Council of the Township of Lopatcong in the County of Warren finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$235,790.84 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of Lopatcong, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Township of Lopatcong shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$235,790.84 and that the CY 2022 municipal budget for the Township of Lopatcong be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, resident of 4 Meadowview Drive, Block 86.07, Lot 55 appeared before the Sewer Appeal Board on January 19, 2022 concerning high quarterly sewer bills; and

WHEREAS, resident explained that during 2020 and 2021, he had to refill his in-ground swimming pool four times. Resident produced various documentation including insurance reimbursement for his flooded basement caused by a problem with his pool filter. The resident used his own hose to refill the pool. The last time, the resident employed the help of a pool cleaner who had to drain and refill the pool due to mold. The pool cleaner verified that the resident again filled the pool via his hose instead of trucking in water and also verified that he had pumped out the pool twice without the water going into the sanitary sewer system; and

WHEREAS, the sewer panel reviewed all the documentation presented and agreed the proof submitted that twice the water did not go into the sewer system; and

WHEREAS, the panel approved a one-time credit to the resident for two fills at 36,300 gallons each time which equates to a Sewer Credit of \$853.05. The resident was instructed to put in a deduct meter on his property to avoid such a situation in the future.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Lopatcong, County of Warren and State of New Jersey do hereby authorize this credit approved by the Sewer Appeal Panel for resident of Block 86.07, Lot 55 in the amount of \$853.05.

Councilman Palitto – Looking to schedule a joint Recreation/EDAC Committee meeting for the third week of the month.

Council President Wright – Asked about the truck situation and where that stands. Clerk Dilts informed the public that summons were issued and the property owners will be scheduled for court. Attorney Campbell stated that the time frames cannot be changed as the property owners have a period of time to rectify the situation. The Zoning Officer can continue to write violations.

Council President Wright asked about the Recreation Program if it will be held this year. Clerk Dilts said it used to be housed at the pool and will need another location; something that can be discussed.

Council President Wright noted that there were interviews for the position of Keyboarding Clerk and a candidate has been decided on.

Attorney Campbell said that a motion would be necessary to authorize to extend an offer to the person discussed in Executive Session for the salary discussed and upon the acceptance of the offer, a Resolution to memorialize the hire would be adopted.

Council President Wright set forth that exact motion as stated by the Township Attorney, seconded by Councilman Palitto. Roll call vote:

Mayor Mengucci – noted there was a second personnel issue.

Attorney Campbell explained that the Tax Assessor made a request for payment for certain required work related to his position in which Council discussed and decided to move forward with what was decided. Motion by Mayor Mengucci, seconded by Councilman McQuade. Roll call vote:

AYES: Councilman McQuade, Councilman Palitto, Council President Wright, Mayor Mengucci. NAYS: None

Mayor Mengucci – informed the public that Engineer Sterbenz would comment on the pool but noted that he would like to put this matter on a referendum allowing the Township residents to make the decision on its fate. It has been a staple in the community since 1967 and it has not been open in the last two years and it would not be open this season. Engineer Sterbenz noted there is a leaking condition and the pool is not holding water. The age contributes to the concrete being cracked and porous at this point along with many other issues including piping over 50 years old. The kiddie pool also has issues.

Department Reports: Motion to approve by Council President Wright, seconded by Councilman Palitto. All in favor.

Payment of Bills: Mayor Mengucci made a motion seconded by Council President Wright. Roll call vote:

John Betz – Talked about the leases being signed and read from a document to the attention of Council.

Donna Schneider – Redevelopment Plan – asked questions regarding the process. Attorney Campbell informed her that a committee will entertain ideas for possible uses and also engage the property owners. This will be reviewed by the Planning Board and put into an ordinance. Asked about the approvals NFI and Bridge have. Asked about videos on the web.

John Ketcherson – Took pictures and asked who to send them too. Clerk Dilts provided the Zoning Officer's email address. Talked about the pool and options for consideration.

Motion to adjourn the meeting by Council President Wright, seconded by Councilman Palitto. All in favor.
