## **Public Comment:**

Judy Liptak – 47 Kyle Drive – Spoke of the Decorum Ordinance and that it should be applied to everyone. She asked about traffic pattern for the Bridge warehouse, a change in the traffic patterns for Rt. 519 and what the Board is doing to change things for the safety of the public.

Chairman VanVliet expressed that the Board's function does not include what Ms. Liptak was asking.

John Kecherson – Questions regarding the Bridge warehouse – verified sewer capacity, truck traffic, staging area established. What is Lopatcong going to do to protect the citizens?

Robert Bruce – 11 Harwich Road – Spoke about truck traffic and what Lopatcong is going to do to protect the citizens-new problem? Confirm direction of truck traffic on existing warehouse on Strykers Road and new warehouse proposed. Commented on the intersection at Strykers Road and Rt. 519 as inherently dangerous.

Beverly Myers – Fairview Circle – Spoke of sewerage from Bridge warehouse that there is not a solution yet on whether it needs to be updated – can it handle the capacity of a new warehouse. Asked about the condition of Strykers Road – what is going to be done about it? Why is it in poor condition? Asked about the porta potties at various locations.

Margaret Taylor -1026 Deerhaven Terrace. What are the pipes that are laying on the side of Strykers Road for?

Chairman VanVliet closed the public portion as there were no more questions and asked for a motion to adjourn. Motion by Mayor Mengucci, seconded by Member Palitto. All in favor.
