ORDINANCE OF THE TOWNSHIP OF LOPATCONG, COUNTY OF WARREN, STATE OF NEW JERSEY, ADOPTING THE REDEVELOPMENT PLAN FOR THE PROPERTY REFERRED TO AS THE PHILLIPSBURG MALL (AREA B), COMMONLY KNOWN AS BLOCK 102, LOTS 9, 9.01, 9.03, AND 9.04 ON THE TAX MAP OF THE TOWNSHIP.

WHEREAS, the municipal council of the Township of Lopatcong, in the County of Warren, State of New Jersey (the "**Township**"), a public body corporate and politic of the State of New Jersey (the "**State**"), is authorized pursuant to the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1 *et seq.* (the "**Redevelopment Law**"), to determine whether certain parcels of land within the Township constitute an area in need of rehabilitation and/or an area in need of redevelopment; and

WHEREAS, in 2021, in accordance with the criteria set forth in the Redevelopment Law, the Township identified and designated the property referred to as the Phillipsburg Mall (Area B), commonly known as Block 102, Lots 9, 9.01, 9.03, and 9.04 on the tax map of the Township as an "area in need of redevelopment" (the "**Redevelopment Area**"); and

WHEREAS, the Planning Board must review the Redevelopment Plan and transmit its recommendations relating to the Redevelopment Plan to the Township Council in accordance with the provisions of *N.J.S.A.* 40A:12A-7 of the Redevelopment Law; and

WHEREAS, upon receipt of the Planning Board's recommendations relating to the Redevelopment Plan, the Township Council believes that the adoption of the Redevelopment Plan is in the best interest of the Township.

NOW THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF LOPATCONG, COUNTY OF WARREN, STATE OF NEW JERSEY AS FOLLOWS:

- **Section 1.** The aforementioned recitals are incorporated herein as though fully set forth at length.
- **Section 2.** Contingent upon the receipt of the Planning Board's recommendations, the Redevelopment Plan, attached hereto as Exhibit A and made a part hereof, is hereby adopted pursuant to the terms of *N.J.S.A.* 40A:12A-7 of the Redevelopment Law.
- **Section 3.** The zoning district map in the zoning ordinance of the Township is hereby amended to include the "Redevelopment Area" per the boundaries described in the Redevelopment Plan.
- **Section 4.** If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Ordinance.
- **Section 5.** A copy of this Ordinance and the Redevelopment Plan shall be available for public inspection at the office of the Municipal Clerk during regular business hours.
 - **Section 6.** This Ordinance shall take effect in accordance with all applicable laws.

Discussed the redevelopment plan and the center designation for Block 102, Lot 9 and Doug Steinhardt sent a plan for the property early in 2022 for a warehouse to Pohatcong. How did Lopatcong not know about this. Escrows have been deposited by the developers for that farmland in Block 102, Lot 9 to have Pohatcong's professionals work on the redevelopment plan. Did Lopatcong get money for our professionals to work? Was Council approached Council about the cubes? Strykers Road trucks are parking on the sides of the roads often.
