TOWNSHIP OF LOPATCONG COUNCIL MEETING 7:00 pm

April 5, 2017

The Council Meeting of the Lopatcong Township Council was called to order by Mayor McKay. The meeting was held in the Municipal Building located at 232 S. Third St., Phillipsburg, New Jersey 08865.

A moment of silence was offered followed by the Oath of Allegiance.

So, I noticed that and also notice there was \$5,000 for legal that I didn't know what that was, not sure what that is. So, could you tell us about that?

Clerk Dilts – I wish you would have told me something ahead of time, I would have asked today but when they put forth – it's a formula so it is 26.25% of the total appropriations from last year and they go through and put enough money in there to get you through the first couple of months. Now the Planning Board you are paying my salary out of it and any legal advertising for the reorganization. Any other business, bills that come in, invoices are charged against escrow for the hearings that we hold

Mayor McKay - Right that's

Clerk Dilts- you know, from the applicants.

Mayor McKay – Applicant money, yeah.

Clerk Dilts – So, I think we're you know, very close, probable enough to get us through till we introduce our budget and we might have to do another 1/12 again

Mayor McKay – Yeah, 1/12 would have been \$24,000 last issue, 1/12 would have been \$2,000 so he didn't realize it. He had looked at some preliminary thing that was done a year before and it was light then so he just copied and went with it. Didn't have time to look at it. So.

Clerk Dilts – I'm sure we can get through it.

Mayor McKay – Well, you know, there's concern. You don't want to not have, you know, a meeting and have all kinds of applicants pounding on the door because we don't have enough money to pay the attorney in the budget.

Attorney Campbell – They applicants pay the attorney.

Mayor McKay – Well, not the Planning Board attorney.

Clerk Dilts – Yeah, they absolutely do the resolutions and stuff yeah, it's all charged against them. The hearings are charge to them.

Mayor McKay – I thought the attorney was paid out of the current fund.

Council President Pryor – He just processed a bunch of Tony's vouchers out of escrow.

Mayor McKay – Well, if they come out of escrow then we should be able to do it. Yeah okay that was a concern. Now the other thing is the \$5,000 for legal for unidentified legal. What's that?

Council President Pryor – My only guess is he's taking legal from last year and (inaudible).

Secretary Dilts – So, anything that comes about as in an invoice would be paid out that.

Mayor McKay – So, no one knows what it is. I didn't see it till I got here.

Secretary Dilts – There is just so much money so that if you need to pay a bill, it is charged to that. It is increased from the first or I don't know this could even be the third resolution (inaudible) it just keeps us moving along in the process until the budget is adopted.

Council President Pryor – I understand. It's just a formula (inaudible) a mistake. So I am going to make the motion we adopt the temporary appropriation.

Council Reports:

Councilman Palitto – Talked about EDAC. Attended the county meeting last month and got some ideas of what can be done in our town. He noted he will schedule a town EDAC meeting for later this month or earlier next month. He also noted he is also looking for members. He asked to put this on the website because other Boards are listed but this one is not.

Councilman Wright – Lori Ciesla offered a report for the Recreation Committee some of whom were present also. She noted they are looking for Recreation to be set up as their own trust fund

which would require a budget line item in the budget. When they get donations right now, they are going into MRNA and CFO Dobes use to track it but we can't charge anything against those donations. She noted last year a budget line item was shared with Brian, Super of Roads.

Council President Pryor said this was discussed with the auditor last year and he said it was possible to do that.

Ms. Ciesla said there are businesses who would like to establish a relationship with us but because we are under the Township, a bidding process would be necessary to establish as required under the Local Publics Contract Law. Would like Council to approve both Beth and Katrina establish an RFP.

Attorney Campbell noted this is through Competitive Contracting – a hybrid between the formal RFP process and a bid.

Councilman Wright made a motion to allow Beth and Katrina to look into and work with the Rec. Committee, seconded by Council President Pryor. Roll call vote:

AYES: Councilman Palitto, Councilman Wright, Council President Pryor, Mayor McKay NAYS: None

Council President Pryor – Third annual Tim Ballis Baseball Clinic May 7th, along with proplayers for the kids. Contact Ken Lutz for more information. June 8th is the golf outing at Architects Golf Club. Rain Garden project has been delayed due to rain and snow. March 29th Rutgers came out and surveyed several sites at the pool and the Strykers Fire House. Brian Weeks met us at the pool and pointed out considerations concerning utilities and the need to maintain access to the gate at the snack bar. Concerns with kids trampling through the garden were raised by Beth which he intends to address.

Litigation updates – Asphalt plant whether you are for, against or neutral – oral arguments were held before the appellate division in Newark on Tuesday, March 28th. I understand that really concludes the lawyers work. It's before the appellate court and what remains now is the decision from the judges. It is up to the judges when they might issue something.

McKay vs. me and others – after two extensions, the Mayor's attorney submitted his brief which I understand was yesterday. Counsel's response is due May 4th and the Mayor's rebuttal is due ten days thereafter. That means briefs will be before the court by mid-May barring additional extensions and then there's the possibility of oral arguments if the decision is made to have oral arguments then that would further extend the schedule and when they are concluded then it's before the judges. So, that's purely a factual report on the schedule.

Engineer Sterbenz – As I indicated a couple of weeks ago in an email to you the Township is a recipient of a \$380,000 grant from the Safe Routes to School Fund for sidewalk and pedestrian safety improvements on Belvidere Road as well as on Strykers Road. These are all locations adjacent to schools. It is a tremendous grant award for the Township. A DOT meeting would be the next step.

He also reported the Police Department has given him documentation on the accidents on Rt. 22 in the area between Rt. 57 and the mall. He will address a letter to the DOT Commissioner in order to get some attention to this matter.

He reviewed the Capital Budget for the Township which included those having to do with roads in the Township. He reported at a meeting a few weeks ago that there was a lot of paving done over a five to seven year period. The pace of that has slowed down due to the economy. An

analysis was prepared on the roads around seven years ago which needs to be updated. He asked the Council if they want him to go forth and prepare an update.

Mayor McKay – Asked if it would be a short report and confirmed it would be inexpensive.

Council President Pryor – Said, he agreed that a five year projection was what they are looking for

Engineer Sterbenz – Confirmed he would just do an analysis on the remaining roads not re-paved for planning purposes.

Chief of Police – Chief Garcia gave his monthly report. Noted the following events: April 1st through the 21st – initiative on statewide crackdown on distracted driving called You Drive, You Text, You Pay. Family Guidance of Warren County will be hosting an event April 6th from 7 to 8 pm – The Truth About Heroin. This would be an educational program. April 13th 7 to 8 pm at the Warren County Community College there will be a criminal justice career fair. Lopatcong Police will be involved with that. Host Operation Take Back in the municipal building in the Police Department a program nationwide 10 to 2 pm for anyone who wants to drop off old medications on Saturday the 29th of April.

Department Reports – Motion by Council President Pryor, seconded by Councilman Palitto. All in favor.

Payment of Bills - \$1,286,969.12 -

Council President Pryor – Asked to confirm Mayor McKay's legal bills are not on the bills list. Correct?

Olschewski – Highlands Way – Asked about the Illusion Maker Program that is funded by a grant. Wanted to know what else would the Township be doing with the money. Council President Pryor noted the many ways in which the money could be spent on. He asked on behalf of the Planning Board about a joint session for any discussions with Larken so all can be on the same page. Council President Pryor noted that is closed session business involving litigation which is a matter for Council. He noted Gary VanVliet was asked into the closed session and asked to invite Eric so we have some insides on what is going on. Attorney Campbell stated the purpose was not to invite someone in so they can tell other people. The purpose was to invite him in for his knowledge and historical background. Council can invite whomever they want into Executive Session. It doesn't change that it is Executive Session. What you are saying she said is to invite Eric in so he can tell the rest of you exactly what Joe is saying

Mr. Olschewski – Said he was not sure why she said that or how you heard that.

Attorney Campbell – Stated you just said let Eric in so the rest of us know is what you just said.

Mr. Olschewski – So, he thought that somebody on the Planning Board should be having some

Attorney Campbell – At the time when it's ready for the Planning Board to know about it, the Council intends to have me write a very comprehensive memo explain in detail everything and perhaps a joint session would be appropriate. The litigation is still ongoing.

Lori Ciesla – 12 Meadowview Drive. She thanked Engineer Sterbenz for all he does – especially the recent sidewalk grant. She asked is the Clean Communities Grant could be used to buy additional garbage receptacles. Council President Pryor said yes to that. She asked about the Tax Appeal on the Phillipsburg Mall how these malls are expanding on ideas other than shopping and suggested EDAC reach out to the folks at the Mall.

Brian Weeks – Regards to Lori and the receptacles at the park. The problem is not the receptacles but the garbage being put into the garbage receptacle. They just leave the garbage on the ground.

John Betz – Brakeley Garden Tenants Organization. Mr. Betz read from Rent Control Statutes in particular cancellation of meetings. Would like the Rent Leveling Chairwoman to be a liaison between Salem Management and the tenants. Attorney Campbell suggested to Mr. Betz that if he has a specific issue that needs to be discussed to let the Board Secretary know about it.

Clerk Dilts – Asked to go back to Resolution No. 17-57 regarding the Temporary Appropriations. She indicated this is the Mayor's charge and should he know the budget items. She noted that if he had questions, that is what the CFO is there for and is in the office often enough to accommodate him. She suggested that since the budget is being prepared that he reach out to the chair people of all his Boards to let them know to get their budget requests in.

Mayor McKay – I thought they had done so. We'll have to work on that again.

John Betz – Noted the library loan access.

Mayor McKay – Motion to come out of public session by Council President Pryor, seconded by Councilman Wright. All in favor.

Mayor McKay – Received complaints on unoccupied houses making the area look blighted. Brought this up before – he asked for an inventory on these homes for tracking. Notices go to the both Zoning and the Tax Collector. The Police Department follows up on these complaints. Attorney Campbell will prepare a standard letter that can be mailed out along with an outline to get through this. Chief Garcia did state his department is on top of it.

Mayor McKay said Phillipsburg Mayor is approaching the County to reduce the traffic speed as it approaches the new high school and assume Lopatcong is on board also. Engineer Sterbenz noted that Lopatcong generated the request originally and the County is waiting for Phillipsburg to actually submit their letter.

Motion to go into Executive Session by Council President Pryor, seconded by Councilman Wright. All in favor.

Attorney Campbell indicated the session should be no more than 30 minutes. Discussion will entail Contractual regarding the LAA and personnel regarding the Police. Action maybe taken.
