Resident Lyn Strouse – Discussion regarding vacation of alleyway bordering his property. 110 South Sixth Street – lived there 42 years and maintained the alleyway running parallel to his home. He asked not to vacate the alleyway for reasons; owner's son said he would do whatever he wants, demolish existing retaining wall and install a new one 10 feet back to his property and lower the grade to the diner's existing elevation. He noted overhead utility wires, and other issues relating to that. Moving the dumpster caused him to deal with stench and rat problem. Has no problem installing retaining wall in existing location. Gregg Theodoropoulos representing the Key City Diner – the wall will stay where it is. Leave garbage container where it was with a fence around it but not moving the garbage towards his house. Would like to vacate alleyway. Mr. Strouse parks his truck and boat on the wall. Asked him not to park there. Engineer Wisniewski – reconstructing an existing wall would require some disturbance to the alleyway as it currently exists. It would essentially be a temporary disturbance that would occur during the reconstruction of the wall; temporary construction easement. Legally, in terms of what agreements would have to be in place, that would have to be discussed. Mr. Strouse agreed to not park on the wall. Engineer Wisniewski also stated that through correspondence and discussion with the zoning official this would be as part of the renovation currently to the diner this would be a minor site plan application. Mr. Theodoropouolos indicated this application would be here to the Township by Tuesday. The reconstruction of the wall and where the trash enclosure would be installed would be part of the site plan application as well as the sign. ORD. 24-04 CALENDAR YEAR 2024 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation

and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Council of the Township of Lopatcong in the County of Warren finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$257,709.90 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of Lopatcong, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Township of Lopatcong shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$257,709.90 and that the CY 2024 municipal budget for the Township of Lopatcong be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
