WHEREAS, pursuant to N.J.S.A. 40A:12-5 et. seq., the Township of Lopatcong, Warren County, New Jersey (the "Township") may acquire lands and real property for public purposes through negotiated agreement, and

WHEREAS, the Township desires to enter into a Contract for Sale of Real Estate with Lopat EMS for the acquisition of (and to consummate such acquisition of) property commonly known as 1301 Belvidere Road and shown as Lot 1 in Block 30 on the official tax map of the Township of Lopatcong (the "Property"); and

- WHEREAS, the Township desires to acquire and utilize such Property for use as recreation and open space; and
- **WHEREAS,** the Township has the assessed value of the property in the amount of \$446,500; and

- Section 1. - Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Township determines the purpose described in Section 2 hereof is not a Current Expense and is an improvement which the Township of Lopatcong may lawfully make as a general improvement.
- <u>Section 4</u>. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.
- Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.

§ 227-4 Violations and penalties.

SECTION 1

Unless another penalty is expressly provided by statute, every person convicted of a violation of a provision of this chapter or any supplement thereto shall be liable to a penalty of not more than \$120 or imprisonment for a term not exceeding 15 days or both, plus court costs.

SECTION 2

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or

invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Councilman McQuade – Nothing additional to report.

Councilman Marinelli – National Night Out - Thank you to the police and all of their hard work organizing/planning for it. Unfortunately, it was cancelled this year.

Council President Palitto – Community Day - The Car Show is back on and the proceeds are going to the Fire Department as well as the proceeds from the Townwide Yard Sale Event. Flyers will be going out this week.

Mayor Wright – We have a part-time traffic enforcement officer for the past two weeks out on the roads. I have been seeing him stop cars everywhere and have heard it on the radio as well. He must stop 20 cars a day and/or tractor trailers on our roads. I'm sure the Chief will talk a little bit about it. It's working out really well. We did have the squad respond to my house today and the Police Department, did it in a very timely manner. It was really amazing to see guys from Phillipsburg and Lopatcong they were right on the scene and I really appreciate that.

Engineer Wisniewski – So the most visible project that we've had over the last month was the Belvidere Road Sidewalk Project. Right around Phillipsburg High School on the Lopatcong side. That work has now been substantially completed. Currently, we've requested an inspection of the project by NJDOT there are some minor items which need to be finalized and completed. Generally, the project has gone very smoothly and we expect the project to be finalized in the coming weeks. Shouldn't be any major disruptions anymore traffic and we don't expect any major disruptions unless some corrective work needs to be done. The next project that I've already spoken on is Jade Lane Project. That work is complete in terms of the drainage repair, sidewalk repairs, manhole repairs there. We are still coordinating on the contractor for milling paving. As soon as we have an update, we will provide that when they give us a date and when they will be in town to do the work. Finally, the Belvidere Road Project has also been completed, the next phase or step in Park progress is we have completed the design of the Pickle Ball Courts at this time and we are finalizing the documents and getting everything ready to get the project in the paper. We hope to have that advertised in the next two weeks. Shortly after that will be open bids and then coordinate on with building the new project in the fall. The next phase of the design of that park project will be to design the pool which we are starting that design process, I believe, in the next two weeks.

Chief Garcia – As you said Mayor effective July 24th, we were able to dedicate traffic enforcement to our roadways and hope to continue with this through the month of August. If I can bring it a little bit future into the month of September, I will but as of right now, we will do it until the end of August. We have seen a lot of vehicles being stopped. It is working and our numbers are increased as you will see slightly just in the week that he was out there. It is making a difference. E-ticketing – E-Ticketing Program is in every patrol car that we have now. So, it's going to be cutting down the time the officers have to be on a traffic stop and holding up the violator so, it's been working great for us so far and it's been running for the last week now. As Councilman Marinelli had indicated that National Night Out was canceled last night due to the inclement weather it's a shame and there are so many people that do work very hard and put that together. I would be remised if I did not thank them. For the businesses that have been phenomenal to our township to make that happen for us every year. So, I would like to thank them in general but also

to our Lopatcong Fire Department Chief LaFord our Lopatcong DPW and Superintendent Brian Weeks, and our Police Department. National Night Out is run by Sergeant, Stephen Gabos, countless hours go into that and it's unfortunate that it had to be cancelled, but we'll see everyone again next year. Our traffic report for the month of July, the Police Department saw a total 198 stops throughout the month of July and then 46% of those stops were issued a summons. Then 36% of those summonses issued were tractor trailers. That's my report for the month of July.

Brian Weeks – DPW Superintendent noted that he has given his report and wants to let them know what's coming down the pike for us. I'm not sure if you've noticed it but we are watching leaves drop and we are going to watch over where Gary VanVliet on Dryden Terrace they will be picked up not too far down the road. We are planning on different things. We've took the dirt from the project up here and made a better area of the leaves so it meets Storm Water Regulations a lot better. It's not going over the hills and right now a lot of it is maintaining and getting everything ready for Community Day. We are also working on all the equipment when it's raining out. We also went out and made sure all of the storm drains were open to eliminate the floods, made sure the detention basins, everything is open before that flood water hits rain wise.

Fire Chief LaFord – For the month of July, the Fire Dept. responded to 14 incidents with an average response time of 7 minutes; our on-scene time was about 40 minutes with 8 personnel and 3 apparatus responding; year-to-date 130 calls. That's down about 3% from last we were at 135 for the same time frame. Our response time for the year 6 minutes with an average incident duration of 32 minutes with 9 people and 4 apparatus.

EMS Report – Month of July the Phillipsburg EMS ran 440 calls of which Lopatcong Township was 105; which was 23.6% of our call volume. Year-to-date the call total is 3,178 of which Lopatcong was 840 - 26.4% of the call volume.

Public Comment:

Bob Bruce – Harwich Road – I wanted to thank Council for listening to the public's calls for restoring Mayor Mengucci's ability for residents to raise comments and questions on agenda items that are in the interest of every resident to clearly and plainly understand what its government is doing and why. I again want to thank the Council for initially adopting the presentation of the monthly traffic reports by Chief Garcia given all the truck traffic and the influx of warehouses has brought to our little Township that was something we asked as residents that you present each month. It has helped to know that the level of enforcement of traffic violations continues if not actually having increased along with the number of trucks. I'd also like to thank Council for adding monthly reports concerning Fire and EMS calls, something I believe that Council independently implemented by themselves without being asked by the residents. Tonight, I'd like to ask the Council to further expand the sharing of monthly reports by beginning short monthly reports on the status of any warehouses known to be planned or thought to be planned. I am aware that additional warehouses on Strykers and an additional warehouse plan behind the mall are

already going in. Can the Council provide monthly reports of the status of these or other warehouses even if it's just to say no change to this warehouse. Just kind of share with the residents where we are regarding warehouses being planned or considered. Can I also ask this Council or perhaps Mr. Lavery who is not here tonight for each month simply note the status of any new or ongoing litigation that we are either defending or prosecuting. I realize what you can say about ongoing litigation is quite limited and that's ok; it's not what I asked that you report on. Also, videos have yet to be posted of the June 26th Planning Board meeting or the June 27th Special Council Meeting.

Lynn Strouse – 110 S. Sixth Street – Due to my persistence with no help from Council at all the dumpster issue with Key City Diner has been resolved. Key City Diner management has been very attentive to this matter. Second, I would like to thank Department of Public Works for painting my handicap space and installing the proper signage.

John Betz – 225 Red School Lane I'd like to thank Council for getting this Ordinance 24-15 second reading and bringing forth the ordinance. I'd like to make a rhetorical statement. What are the intentions of the Rent Board enforcing the Ordinance. There is a tenant that I spoke with today that has an attorney, their attorney has not been responded to either. So, that puts a personal attorney not responding to. I know for the longest time Lopatcong's attorney had responded to by our group.

Richard Markle– 1400 Belvidere Road – First, I think the Police Department having a designated traffic person is needed. I live right there on the corner of Red School Lane and Belvidere Road. There are continuous trucks coming through, they're overweight and I don't know what we should do about the speed limit. They are coming through there at 50 + mph. September, October, November, December we should keep the continuous traffic cop to handle that. Second comment is, I don't know what our policy is in Lopatcong with illegal immigration. It's not a Texas issue, it's not an Arizona issue it's everywhere but I've never heard a conversation about it in our town. Are they coming to our schools? If we're not already talking about it, we should be. Comment number three, is the sidewalk going all the way down to Red School Lane. Is that happening next year? Are the plans finalized?

Mayor Wright – Indicated he would find out and get back to him.

Pam Thomas – 6 Wordsworth Lane – I do need to say any comments or ideas I have are strictly my own and not as a representative of the school board, which I am a member of. So, first of all I would like to say I just love to see the sidewalks on Belvidere Road and I have a question about Charles and Belvidere Road. Will there be a crossing guard or is there discussion of a future traffic light there? It's a tough situation. So, now the sidewalks are there for the kids so they can get to the high school, but how do they get across Belvidere Road. I'm concerned about their safety.

Mayor Wright – I will check on it and get back to you.

Mayor Wright called for an adjournment of the meeting. Motion by Council President Palitto, seconded by Councilman McQuade. All in favor.
