Mayor Mengucci – Reported that there is a need to hire additional help in the Tax Collector's Office and would like to extend an offer to an individual. Attorney Campbell noted that the motion would include the person and salary discussed in Executive and then if person accepts the offer, we will have a formal resolution at the next meeting. Engineer Sterbenz – Reported that the final payment was authorized at the last meeting for the Baltimore Street Improvement Project. A final inspection was performed by the Dept. of Transportation with one comment that several of the stop signs at the South First Intersection were too low. This has been coordinated with Brian and this has been addressed. The paperwork was completed and submitted to the Dept. of Transportation so the \$45,000.00 can be disbursed to the Township.

The Bid documents for all the sanitary sewer and storm sewer repairs was advertised and out to bid. The bids will be opened on the 12th next week. The roadway improvements and striping has been submitted to the Dept. of Transportation to be reviewed and approved by that department. The work will be completed as long as the weather and Tilcon's scheduling doesn't interfere with completing Red School Lane in 2019. The flashing school sign has been completed on Strykers Road as well as County Route 646 and are operational at this point. The Sally Port plans and bid documents are substantially completed and will seek authorization to bid at the October 2nd meeting.

Council President Pryor – Asked if there was an update on Bridge's improvements on 22 as far as the schedule.

Engineer Sterbenz – noted that they advanced the project. The curbing has been installed and the DOT work is advancing and plans are being followed. The DOT took a long time to issue the permits.

Council President Pryor asked Chief Garcia if there are interlocks on the doors or anything like that.

Chief Garcia – Said right now they have magnetic locks operated from both sides.
