LAA Donation – Agreement with LAA in return for services provided under the terms of the agreement a stipend of \$7,500 would be paid. Services were not completed but stipend will be paid with the understanding that services must be completed as soon as practical after the winter in 2020 before a new agreement can be executed.

Council Reports -

Councilman Palitto – LAA – Sean Leahey was elected to be the President of the LAA and will begin his term in January. Wished all a Happy and Safe New Year.

Councilman Wright – Vulture Issue – Asked Clerk Dilts to provide an update. A recommendation from the Animal Control Officer and County Health Dept. to include language in the Township's Ordinance to be able to enter onto private property to deal with situations such as this. The County Health Dept. did reopen the case. Another complaint was lodged with her office and this is an ongoing investigation.

Council President Pryor – The Phillipsburg Sewer Agreement was finalized with a new agreement to be enforce over the next four years beginning in January 2020. In addition, a new Rate Ordinance was put in place by the Town of Phillipsburg to reduce the Township's rate; an 8.5% rate reduction through 2023 relative to what is paid to Phillipsburg now for sending sewerage to their treatment plant. A rebate will also be provided annually in the amount of \$101,000.00 over the next five years in the way of a credit. Also, approximately \$298,000.00 is owed to the Town of Phillipsburg from Lopatcong for connection fees. This reconciles all the

claims and counterclaims. There will be no increase in the pilot during the term of the agreement. Phillipsburg is facing a lot of improvements to its collection system to which Lopatcong will not be required to contribute to the cost of maintenance, repair or upgrades to the Town of Phillipsburg's sewer collection system except for the portions that are used.

Council President Pryor informed the public that he would like to introduce a "Pot Hole Hotline" for folks to call in and report a pothole. He requested Clerk Dilts and DPW Superintendent Brian Weeks put together the process to handle this going forward.

Thanks all the volunteers for their assistance this past year; without volunteers many of the Township's programs and boards would not be sustained.

Mayor Mengucci – Echoed the words of Council President Pryor regarding the value of the volunteers and the staff.

<u>Payment of Bills</u> – Added a tax refund and a check to the LAA for \$7500.00 and a subtraction of Cooper Electric. Motion by Council President Pryor, seconded by Councilman Wright. Roll call vote:
