A Prayer was offered followed by the Oath of Allegiance.

Mayor Mengucci stated "adequate notice of this meeting has been provided indicating the time and place of the meeting in accordance with Chapter 231 of the Public Laws of 1975 by advertising a Notice in The Star Gazette and The Express-Times and by posting a copy on the bulletin board in the Municipal Building."

Attorney Campbell noted that Council was in Executive Session for approximately one hour to discuss the matters listed on the agenda with one addition; contract for website design.

## Presentation -

**NFI Real Estate**– Attorney Mark Peck represented the company who is interested in building a 592,800 square foot warehouse on approximately 46.75 acres located off of Strykers Road in the ROM District on Block 99, Lot 3.01. The land is currently outside the Township's sewer service area. They would like the Township to amend Wastewater Plan to include the sewer service to include this particular block and lot. Representatives from NFI went through the project concept and noted they met with the Highlands and other professionals who provided positive feedback to them. Council President Pryor noted this is a conforming use. Lopatcong is one of the few towns in the County that has an approved Wastewater Plans. We don't have enough capacity to serve the existing sewer service area but the boundary could be extended. This has to be studied further to determine what the capacity is at right now. Council President Pryor noted that Council has to see what the infrastructure will look like and what capacity you are looking for before a determination could be made.

Ordinance No. 20-07 – Second reading and public hearing of an Ordinance of the Township of Lopatcong, County of Warren and State of New Jersey amending and supplementing Article II, "Base and Use Charges", and "Initial Service Charges" of the Code of the Township of Lopatcong to Implement Updated Sewer Charges, Connection Fees and Collection Procedures. Attorney Derek Orth stated this is a second reading and the final item that had to be accomplished from the litigation with Phillipsburg. The initial sewer connection fee was not changed in over 20 years. A study was performed by Nisivoccia, the Township's auditors along with Engineer Sterbenz and CFO Browne. It was determined that Lopatcong's portion of the connection fee would be \$1364 per dwelling unit. Currently, the Township collects \$2,000 which \$1,000 of that goes to Phillipsburg. This ordinance now requires Phillipsburg's portion of the connection fee payment to go directly to Phillipsburg and Lopatcong collects its portion only. The sewer rate for Lopatcong residents has been reduced after the base rate. A discount for COAH units in a development, through state law, had the connection rate reduced by 50%. In subsection B of Section 2 add a sentence "the design flow rate and projected flows referenced in the ordinance are strictly for purposes for calculating the connection fee and are not applicable for TWA approval permit applications or any other agency approvals". Also, another statutory revision that happened two years ago provides a revision to the code that someone with an

existing connection and come back to the town on a land use application and say they want to use the same connection they would have to provide a connection fee for the increase in the flow that arrives as the result of the proposed development. WHEREAS, a new road has been constructed to service Lots 6 and 6.07 in Block 100, including an asphalt plant on Lot 6 in Block 100; and

WHEREAS, pursuant to the resolution of approval that allowed for the subdivision and subsequent development of Lot 6 in Block 100, the Township of Lopatcong is not responsible for the maintenance of the roadway; and

WHEREAS, pursuant to Condition 1q of the resolution of approval for the subdivision and site plan approvals for Lot 6 in Block 100, the developer was required to request Title 39 enforcement from the Township upon completion of the roadway; and

WHEREAS, the roadway within Lot 6.08 in Block 100, is now complete; and

WHEREAS, North State Materials LLC submitted a request for Title 39 Enforcement to the Township on April 18, 2020 pursuant to Condition 1q of the Planning Board resolution of approval; and

WHEREAS, the Township Council reviewed the April 18, 2020 request of North State Materials LLC at its May 6, 2020 meeting; and

WHEREAS, the Township Council of the Township of Lopatcong, County of Warren, State of New Jersey, desires to supplement and amend Chapter 227 of the Code of the Township of Lopatcong in order to add Section B(6) to regulate the movement and parking of traffic through Title 39 enforcement on the access road for Lots 6 and 6.07 in Block 100, which is situated within Lot 6.08 in Block 100;

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Lopatcong, County of Warren and State of New Jersey that Chapter 227 of the Code of the Township of Lopatcong be supplemented as follows:

# SECTION 1

## §227-38(B)

- (6). Access Road for Lots 6 and 6.07 in Block 100 situated within Lot 6.08 in Block 100.
  - a. General Parking.
    - 1. No parking is permitted on the access road.
    - 2. No person shall stop or stand a vehicle on the access road.
  - b. Speed Limits.
    - 1. The speed limit on the access road shall be 25 miles per hour.
    - 2. Regulatory and warning signs shall be erected and maintained to affect the above designated speed limits.
  - c. Stop Intersections.
    - 1. The following streets or parts of streets are hereby designated as stop intersections. Stop signs shall be installed as provided thereon.

IntersectionStop SignStrykers Road and Access Road for 1 Access Road for Lots 6 and 6.07 inBlock 100Lots 6 and 6.07 in Block 100Block 100.

d. Tow-Away Zones.

Any vehicles parked or standing so as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills, any grassy area pedestrian walkway, or present in any way a safety or traffic hazard may be removed by towing the vehicles at the owner's or operator's expense.

## **SECTION 2**

<u>Severability.</u> The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

## **SECTION 3**

<u>Repealer</u>. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

## **SECTION 4**

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.

**Block 99, Lot 256, C0919** – Request to waive interest on missed payment. Attorney Campbell stated that this is a potential payment plan and this will be brought back at the next meeting for a formal approval.

**Tax Interest – 2Q 2020** – Request to waive 2Q, 2020 interest. The governor put out an Executive Order which addressed an extension deadline for taxes could be June 1<sup>st</sup>. Twelve municipalities in Warren County did not extend their dates and Lopatcong was one of them. Attorney Campbell said it could do so, it was may, not a shall, but the governing body would have had to adopt a resolution which had to go to the Division of Taxation within three days. The Council decided to

not extend the deadline and this was put on the record at the last meeting. The website said we will notify you if it gets extended and notification was not provided to extend the date. There were some people who were confused and did not hear the exact words. A handful of residents did not pay on time. They have asked the tax collector to waive interest and she cannot by law do that over ten dollars. Mayor Mengucci said the payments must be made to the County and the School on time. Council opted to not consider the waiver.

**Resolution No. 20-88 DOT** – Support bridge work located on Rt. 57 east of Rt. 519. Council President Pryor noted that there are two resolutions one of which he added some additional language to make it clearer; one being he added to maintain two lanes for traffic for the duration of the project.

Explanation: This resolution conditionally supports the proposed NJDOT project entitled" Rt.57 Bridge over Branch Lopatcong Creek".

WHEREAS, the NJ Department of Transportation (NJDOT) has proposed the project entitled "Rt.57 Bridge over Branch Lopatcong Creek" which is in need of replacement due to its age and condition; and

WHEREAS, the NJDOT has ultimately deemed the bridge structurally deficient and functionally obsolete, recommending replacement; and

WHEREAS, the proposed construction staging for the NJDOT's Preliminary Preferred Alternative is to install a temporary traffic signal on each end of the bridge; and

WHEREAS, the NJDOT proposes to maintain one lane of alternating traffic across the bridge during construction; and

WHEREAS, the anticipated construction duration is expected to be  $1^{1}/_{2}$  years; and

WHEREAS, there are existing traffic problems at the intersection of CR 519 and SR 57: and

WHEREAS, the Township is aware of major land development(s) proposed along roadways within and adjacent to the Township; and

WHEREAS, the Township anticipates a significant increase in traffic volume on the roadway network in the vicinity of the project area as a result of the new development(s); and

WHEREAS, the Township is concerned the new development(s) will result in a significant increase in traffic along Rt. 57 and adjacent roadways; and

WHEREAS, the Department (will) has agreed to re-evaluate the proposed construction staging for the "Rt. 57 Bridge over Branch Lopatcong Creek" project, based on an updated traffic analysis performed in the preliminary design phase of the project; and

WHEREAS, (including) the updated traffic analysis shall include projected traffic generated by the land development(s) (on) scheduled to be completed before the start of construction on the project.

NOW THEREFORE BE IT RESOLVED, by the Township of Lopatcong, in the county of Warren, NJ that we do hereby support the proposed "Rt. 57 Bridge over Branch Lopatcong

## RESOLUTION OF THE TOWNSHIP OF LOPATCONG, COUNTY OF WARREN AND STATE OF NEW JERSEY AUTHORIZING THE TAX COLLECTOR TO PROCESS THIRD QUARTER "ESTIMATED" TAX BILLS, DUE AUGUST 1, 2020

WHEREAS, in light of the disruption caused by the coronavirus outbreak, the State delayed the adoption of the State Fiscal Year 2021 budget to September 30, 2020; and

WHEREAS, the Division of Local Government Services (DLGS) cannot certify State Aid allocations to municipal budgets until State Aid Appropriations are known; and

WHEREAS, the DLGS cannot approve municipal budgets and the County Board of Taxation cannot certify taxes until long after the June 30, 2020 deadline to process third quarter tax bills due August 1, 2020; and

WHEREAS, without ad adopted 2020 municipal budget and without a 2020 certified tax rate, the Tax Collector cannot process the final 2020 Tax levy; and

WHEREAS, the DLGS "strongly recommends" under Local Finance Notice 2020-07 "that municipalities prepare to issue estimated property tax bills for 2020; and

WHEREAS, the Tax Collector, in consultation with the Chief Financial Officer, computed and certified an estimated Tax Levy necessary to bill third quarter taxes due August 1, 2020.
