The Regular Meeting of the Lopatcong Township Council was called to order by Mayor Mengucci. The meeting took place at the Municipal Building Court Room located at 232 S. Third Street, Phillipsburg, NJ.

Generator Replacement Project – Authorize purchase and installation of generator at the Municipal Building in the amount of \$75,782.32 from P3 Generator Services pursuant to contract through New Jersey Start Program. Motion to authorize by Council President Pryor, seconded by Councilman Wright. Roll call vote:

2020 Best Practices Inventory – CFO Browne explained the Division of Local Government Services puts out a survey each year; this year had 60 questions on it and some of those were ranked and some were not so if you score really low it affects your state aid. Lopatcong does not have that problem. Out of the potential points of 24.5, Lopatcong scored 22. There is not deduction in the state aid for Lopatcong. This has been submitted and approved.

Warehousing ROM Zone – Council President Pryor stated that Lopatcong and the County in general are experiencing increased interest in warehousing and in September the County issued a draft report which identified 15 sites comprising 4500 acres and 45 million square of gross floor area for the total of warehouses. Lopatcong has strived to balance development. There is such an interest here that Lopatcong is starting to look unbalanced with two projects; Ingersoll Rand site and Strykers Road. On the east side of Strykers Road there is approximately 250 acres there that could accommodate roughly the same as on the west side. Truck traffic is an issue as well. Once a project gets to the Planning Board, there is very little control over off site traffic. The courts have determined that if you did not like the traffic, the zoning should not have allowed it. Council President Pryor stated that it might be time to eliminate warehousing as a permitted use in the ROM District; take a break and experience what is now here in Lopatcong. Mayor Mengucci agreed stating also that there is not control over what goes on in other townships that are also experiencing warehousing and what road routes will be used by trucks. Council President Pryor thought the introduction of an ordinance to strike warehouses out of the ROM Zone. Councilman Belcaro said he agreed with the Mayor and Council President Pryor that there has to be a balance and this is the time that the balance could be lost; sometimes the revenue is not worth it. Attorney Campbell stated that in order to accomplish this introduction of Ordinance 20-12 to Amend, Supplement and Revise Land Use Zoning Ordinance Sections 243-75A to eliminate No. 2 – Warehouse and Distribution Centers as a permitted use and also to Amend Section 243-77.3C1C to delete the Section in its entirety. Motion by Councilman Belcaro, seconded by Council President Pryor. Roll call vote:

Attorney Campbell noted this ordinance will be listed for the second reading and public hearing for December 2nd and in the meantime, it will be sent over to the Planning Board for their review.

ORDINANCE NO. 20-12

ORDINANCE OF THE TOWNSHIP OF LOPATCONG, COUNTY OF WARREN, STATE OF NEW JERSEY, TO AMEND AND REVISE CHAPTER 243 ENTITLED "ZONING AND LAND USE" TO DELETE SECTIONS 243-75(A)(2) AND 243-77.3(C)(1)(c) TO REMOVE WAREHOUSES AND DISTRIBUTION CENTERS AS PERMITTED USES IN THE ROM AND PD ZONES.

WHEREAS, the Lopatcong Township Council wishes to amend its Land Use and Zoning Ordinance to remove warehouses and distribution centers as permitted uses in the ROM and PD districts.

NOW THEREFORE BE IT ORDAINED by the Council of the Township of Lopatcong, County of Warren, State of New Jersey that Chapter 243 entitled "Zoning and Land Use", Sections 78.1 and 83 are amended and revised as follows:

Section 1

Section 243-75 ROM Research Office and Manufacturing Zone, Subsection A shall be amended to delete Subsection 2.

243-75(A)(2) Warehouse and distribution centers.

Section 2

Section 243-77.3 PD Planned Development Overlay District, Subsection C Use Regulations, Subsection (1) Principal Uses shall be amended to delete subsection (c).

243-77.3(C)(1)(c) Flexible office/warehouse uses, provided that no building is located within 400 feet from the right-of-way of U.S. Route 22.

Section 3

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder off this Ordinance shall not be affected thereby.

Section 4

<u>Repealer</u>. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 5

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.
